

THE RECTOR

- Having regard to the Ministerial Decree of 8 February, 2013, n. 45;
- Having regard to the Regulations for the PhD Programmes at LIUC-Università Cattaneo issued by Rectoral Decree n. 257 of 23 April, 2014;
- Having regard to the Regulations for the PhD Programme in Management, Finance and Accounting - XXXII Cycle of LIUC-Università Cattaneo, issued by Rectoral Decree n. 33 of 23 March, 2016;
- Having regard to the Rectoral Decree n. 34 of 23 March, 2016 notice of which was published in the Official Gazette of the Italian Republic on 29 April, 2016, the Fourth special series, n. 34;
- Having regard to the resolution of the Management Committee of 20 April, 2016 in which, following the communication of ENEA concerning its intention to co-finance 50% of a three-year scholarship on of the XXXII cycle of the PhD Programme, is conferred authority to the Rector to define the details of the proposal, stipulate a special agreement and achieve the requirements related to the integration of the call;
- Having regard to the letter of intent of ENEA - National agency for new technologies, energy and sustainable economic development of 28 April, 2016;
- Considering that it is necessary to integrate the call for admission into the PhD Programme in Management, Finance and Accounting - XXXII cycle;
- Considering that, also, it is necessary, appropriate and sufficient a form of advertising of the integration of the call, also supplementary advertising, with the publishing, electronically, on the website of the Università of the present Decree;
- Considering that it is necessary, appropriate and sufficient supplementary variation of the terms of the application, with respect to the principle of objective knowledge of the elements of the call.

DECREES

The enactment of the following Article 3a of the Rectoral Decree n. 34 of 23 March, 2016:

Article. 3a - Co-financing by external Entities

For up to 6 places with exemption from contributions for access and attendance and enjoyment of scholarships there is activated a scholarship co-funded by ENEA - National agency for new technologies, energy and sustainable economic development for a programme of research, entitled "Socio-economic impact of the participation of Italian companies in the construction of the international scientific-technological project, ITER", having the following objectives:

- Socio-economic impact assessment of the participation of Italian companies in the construction of the international scientific-technological project, ITER;
- Impact assessment of the knowledge produced on social, cultural and economic development;
- Potential impact assessment of the implementation of a national project attached to it.

Expected results:

- Quantitative analysis of the economic multiplier for companies, job growth, inducement, networking, new market opportunities, possible changes in production processes, internationalization;



- Analysis of technology transfer, “know-how” and innovation;
- Analysis of the economic and strategic relevance of the results in the Italian economy;
- Analysis of the results of public engagement;
- Development of an analysis model and socio-economic impact assessment of large public projects (international).

The process of selection of applicants for the awarding of the scholarship, referred to in the present Article, shall be taken into account, in the context of the three profiles a), b) and c) of Article.7 of the Rectoral Decree n. 34 of 23 March, 2016, of the coherence of skills with the objectives and results of the programme described above.


It also provides the extension of the submission deadline of the application by defining the new expiration as the 15 June, 2016, at 17:00.

It provides that the present Decree should be given appropriate, necessary and sufficient communication through publication, electronically, as cited in the introduction, as well as communication to applicants already registered.

The present Decree shall be drawn up in the Italian language and translated into English. In case of contradiction and/or different interpretation of individual parts, the text drawn up in the Italian language shall prevail.
