MINUTES N. 2

On the 28th of September 2023, from 9:00 am to 11:45 am, in Sala Riunioni at the ground floor of Torre Building, the Selection Committee of the "Concorso" for admission onto the PhD programme in "Management, Finance and Accounting (hereinafter referred to as "the programme") - XXXIX cycle" appointed by the Rectoral Decree n. 1070 of July 20th, 2023, held its second meeting of the "Concorso" to which it applied the legislative provisions on public "Concorsi" to carry out the oral tests via remote call and in person.

Following Prof. Massimiliano Serati's communication of his inability to attend in the morning as a member of the Selection Committee, Prof. Andrea Venegoni was appointed by the Rectoral Decree n. 1081 of September 20th 2023 as substitute member, limited to the performance of the test scheduled for today and tomorrow.

The Committee declared the absence of incompatibility, according to the article 51 of the Civil Procedure Code and article 7 of Presidential Decree 62/2013, of among the members and between them and the applicants.

With reference to the positions financed by the NRRP funds, the Committee acknowledged all the provisions contained in the Ministerial Decree of 2 March 2023 no.118 attributing NRRP financing (Mission 4.1 "Enhancing the offer of teaching services: from nurseries to universities" – Investment 3.4 "Advanced university teaching and expertise" and Investment 4.1 "Expanding the number of PhDs and innovative doctoral courses for public administration and cultural









heritage") for 3-year PhD scholarships within the XXXIX cycle, within the areas of interest of the NRRP.

Prof. Emanuela Foglia was connected via Ms Teams for today's meeting.

The Selection Committee identified the criteria for the evaluation of the oral test:

- ability to analyse and to discuss economic and social phenomena with a scientific approach;
- motivation towards scientific activities;
- solving test of general knowledge and logical reasoning
