MINUTES N. 3

On the 29th of September 2023, from 9:15 am to 10.00 am in Sala Riunioni at the ground floor of Torre Building, the Selection Committee of the "Concorso" for admission onto the PhD programme in "Management, Finance and Accounting (hereinafter referred to as "the programme") - XXXIX cycle" appointed by the Rectoral Decree n. 1070 of July 20th, 2023 and Rectoral Decree n. 1081 of September 20th 2023, held its third meeting of the "Concorso" to which it applied the legislative provisions on public "Concorsi" to carry out the oral tests via remote call and in person.

With reference to the positions financed by the NRRP funds, the Committee acknowledged all the provisions contained in the Ministerial Decree of 2 March 2023 no.118 attributing NRRP financing (Mission 4.1 "Enhancing the offer of teaching services: from nurseries to universities" – Investment 3.4 "Advanced university teaching and expertise" and Investment 4.1 "Expanding the number of PhDs and innovative doctoral courses for public administration and cultural heritage") for 3-year PhD scholarships within the XXXIX cycle, within the areas of interest of the NRRP.

The Selection Committee reassert the criteria for the evaluation of the oral test as defined on the meeting of September 28th 2023:

- ability to analyse and to discuss economic and social phenomena with a scientific approach;
- motivation towards scientific activities;
- solving test of general knowledge and logical reasoning

Applicant Rehmat Sana did not respond to multiple contact attempts made in the morning and was therefore considered absent from the oral test.

All applicants were identified by reference to their identity document and submitted to the interview.

The committee declared that the selection procedure respected, where relevant, the following transversal principles as set out in EU Regulation 2021/241: a) the principle of gender equality; b) the principle of the promotion and valorisation of young people; c) the principle of overcoming territorial disparities.

The Selection Committee will meet on Tuesday 3rd October at 8.30 am via Ms Teams to define the ratings for Profile C and the final ranking.
